The Project consists of the installation of approximately 28,000 LF of 12-inch DIP waterline, along with related fittings, hydrants, system connections and other appurtenances. The project also includes new service connections, asphalt repair, erosion control, grassing, and restoration to equal or better condition.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.
